



RULES & REGULATIONS 2022

1. Proper attire is required by management. Permissible footwear (for all players) includes non-metal / penetrating or spikeless golf shoes or sneakers. A collared shirt is also required.
2. Rainchecks will not be granted due to forecasted or imminent, inclement weather.
3. No golf membership dues refunds of any type will be considered once the current golfing season has commenced.
4. All players are required to register in the pro shop, prior to beginning play.
5. All players must register with the starter, prior to beginning play.
6. All players must begin play on the first tee unless permission has been received from the pro shop.
7. No more than four (4) players per group, will be permitted, unless authorized by the pro shop staff.
8. All players are to be aware of the USGA Pace of Play Rating, noted on the scorecard. Accordingly, all players are expected to complete their round within this established timeframe. (*Pace of Play Policy can be found on the first tee*).
9. All groups must keep their position on the course behind the group in front of them, not in front of the group behind them.
10. Slow groups falling behind by more than the one hole spacing, provided at the beginning of their round, will be asked to pick up the pace of play and thereafter, will be asked to pick up their balls and move forward to the correct position.
11. Each player must have their own set of clubs and golf bag. Players are not permitted to share a set for any reason.
12. All players must use the tunnel traveling under Haddonfield Rd. This has been provided for the safety of all customers.
13. During your round, repair all ball marks, replace all divots, and rake all played bunkers.
14. Wave up the group behind you on hole number 7.
15. A maximum of two players and two golf bags will be permitted per motorized golf cart.

16. Individuals who rent motorized golf carts as a single are not permitted to give rides to those players who are walking.
17. Motorized golf carts must be kept outside all areas designated by directional signage, rail fencing, and ropes. Management and course staff maintain full discretion to issue further directives as to permitted and non-permitted areas during any player's operation of a motorized golf cart.
18. Motorized golf carts should be kept on the cart paths when in the area of any teeing grounds.
19. Motorized golf carts must be returned upon completion of the holes paid for unless additional rental fees have been paid.
20. Hand carts are prohibited from being pulled onto the apron of any putting green.
21. Starting times are required by all players using the facility unless a player is a single.
22. All players not part of a group (singles) must report to the starter, to be paired with players waiting to begin play.
23. Any player(s) or groups found to be abusing the privilege of making advance starting time reservations will be reprimanded in the following manner: **a)** Verbal warning. **b)** Written warning. **c)** Loss of starting time reservation privileges for the player and or group.
24. The starter has full authority as to the order of tee off, with regards to reserved starting times.
25. It is better to have a starting time reservation and cancel, than to expect to be "squeezed in".
26. All groups with reserved starting times must be present and checked in with the starter at least fifteen (15) minutes prior to starting time.
27. Any group that is late for their designated starting time will be placed in the next available opening on the starting time sheet.
28. Alcohol and illicit substances are prohibited from being stored in any locker that is the property of the facility.
29. No coolers will be permitted on the golf course.

30. Alcohol may be consumed on the course in moderation. Consumption must not lead to unsafe or unacceptable behavior. Any person visibly intoxicated will cease to be served. Management reserves the right to request any visibly intoxicated person to leave the premises.
31. Deposit all litter in the appropriate receptacles located throughout the golf course. Abuse to the golf course will not be tolerated for any reason. Any player found doing so will be asked to leave the premises immediately.
32. The act of physical violence against any individual is forbidden. Should this occur, said individuals will be asked to leave the premises immediately and if needed, the local authorities will be notified.
33. All players must be considerate of their surroundings, during their round.
34. In the event of a disruptive situation, please contact an employee of the facility immediately.
35. All members and players have the right to use and enjoy the club's facilities without undue disturbance or interference by others. All members and players must be considerate of others, including staff and club property.
36. Unacceptable, unreasonable, or unbecoming behavior will not be tolerated. Such behavior includes but is not limited to **a)** Any form of sexual, racial, religious, or other harassment. **b)** Any form of flagrant, abusive, threatening, or violent language or behavior. **c)** Any form of bullying; whether physical or verbal. **d)** Intentionally defacing, damaging, or removing any club property without prior authorization from management.
37. Management reserves the right to suspend, revoke, or not renew membership for violations of these rules and regulations. Management also reserves the right to remove any player or terminate playing privileges of any player for violation of these rules and regulations. Any disciplinary action shall be at the sole discretion of management.
38. By applying for membership in the club, every member is deemed to have read, understood, and agreed to these rules and regulations.
